Applications are invited from the **non-gazetted serving Railway employees of Group-C** in pay matrix **level-5 and above** of HQ unit, Construction Organization, MD/CH/MLG, Dy. CMM/PNO, Railway School(s) at MLG, Dy. CE/Br. line/MLG, Principal S&T/Training School/PNO, Track Machine Organization/MLG& other HQ controlled units, whose ward(s) are admitted in higher technical/professional courses in the year **2024** for grant of monthly scholarship @ Rs. 1,500/- per month.

The terms and conditions for the grant of scholarship are laid down as under: -

- 1. Higher technical/professional scholarship is admissible for the following courses where study is continued from such college/institute/university which are recognized/affiliated by Govt. of India/State Govt./Recognition Boards.
 - a) Degree/Post Graduate courses in Medicine including Homeopathy, Ayurveda, Unani system of medicine, Pharmacy, various branches of Engineering, Computer Science, Architecture, Environment Planning, Veterinary Science and Animal Husbandry, Agriculture, Nursing, IT, Bio-Technology, Microbiology, Textile courses from Textile Institute of Technology, Computer application, Business administration, Business management, ICWA, CA.
 - b) Degree Courses in Pure Science.
 - c) Diploma courses in Medicine including Homeopathy, Ayurveda, Unani system of medicine, Pharmacy, various branches of Engineering, Computer Science, Architecture, Environment Planning.

- d) Other courses included are L.L.B. (3 & 5 year) & B.A.L.L.B. (HONS) & L.L.M., B.Sc/M.Sc (Forensic Science), M.Sc (Biotechnology/Molecular Biology), B.Sc & M.Sc in Biochemistry, Chemistry, Environmental Science, Forensic Science, Food Technology Genetics, Industrial Chemistry, Microbiology, Nutrition and Deictics, Pharmaceutical Chemistry, B.Sc & M.Sc in Anesthesia, Critical Care, Cardiology, Renel Dialysis, Emergency Medical Services, Medical Laboratory Technology, Neurology, Operation Theatre Technology, Optometry, Radiography, B.Sc & M.Sc in Public Health, Hospital Administration, Health Economics & Technology Assessment, Bachelor & Masterof Physiotherapy, Degree & Masters of Applied Phycology, Hospital Management, Journalism & Mass Communication, Bachelor & Masters in Music, etc.
- 2. Scholarship will be payable on the basis of scholastic/academic records and on submission of pass certificate/mark sheet along with **Continuation Form** (semesterwise/year-wise) **from the session January/2024**.
- 3. The scholarship once sanctioned will not be affected by death/invalidation or retirement on superannuation of the employee.
- 4. The application for grant of scholarship will not be considered/will be rejected in the following circumstances:
 - i. The institute/university is not recognized by the Government.
 - ii. Incomplete application form.
 - iii. Any other scholarship is granted by the Government or Institution where the ward(s) is/are studying.
 - iv. Application received beyond last date i.e., 29.11.2024.
 - v. The ward(s) is/are re-employed as casual labour and substitute staff, etc.
- 5. The non-gazetted Railway employees who fulfil the above criteria may fill the enclosed application form and scan the required documents as mentioned along with the form in one single pdf file and upload it to the google form link-https://forms.gle/ZciDxsH4Zb5x2vM57 on or before 29.11.2024.
