Yoga Instructor/Teacher	Diploma in "Yogic Studies" from recognized institution

Age Limit: Not exceeding 45 years of age.

Contract period:- 1(one) year from the date of engagement.

Honorarium: ₹17,500/- per month consolidated.

1. The selected candidate will be engaged by the Chairman, Central Staff Benefit Fund Committee, N. F. Railway and he shall not be considered as a Railway Employee. The engagement will be purely on temporary basis for a period of one year, which may be extended from time to time depending upon the requirement and other terms and conditions.
2. Eligible applicants will be called for interview.
3. The engaged person will have to work in Maligaon area. Location will be decided later on.
4. Weekly one day rest will be allowed.
5. Deduction will be made on pro-rata basis from the consolidated monthly honorarium for absence.
6. No TA/DA shall be admissible for appearing in the interview.
7. No railway Quarter will be provided to the engaged person for the above post. No fooding facility will be provided by the administration.
8. Without hampering the assignment entrusted by the CSBFC/N.F.Railway, the selected candidate can perform private practice.
9. No medical treatment facility, Pass etc. will be extended by the railway to the selected/engaged candidate.
10. The services of the engaged candidate can be terminated on 14 days notice by the Chairman CSBF without assigning any reason.
11. Time for Yoga class will be decided in due course. However, classes will be held for a minimum of 04 (four) hours in a day preferably 02 hours in morning and 02 hours in evening.
