Sub: Safety Related Retirement Scheme (SRRS) renamed as Liberalized Active Retirement Scheme for Guaranteed Employment for Safety Staff (LARSGESS).

Application are called from the staff working against safety category post in the following Departments who fulfill the criteria as given below.:-



1.	Operating	Pointsman, Shuntman, Leverman, Gateman, Traffic Porters & Trolley Man
2.	Civil Engineering	Gateman, Trolleyman, Keyman, Gangman/ Trackmaintainer in GP-₹1800 & GP-₹1900/-
3.	Mechanical & Electrical	Khalasi/Khalasi Helper re-designated as Helper Gr.II & Gr.I assisting Loco Fitters/ C&W Fitters/ Fitters in Diesel Sheds & Train Lighting, AC fitters, Trollymen, Crane Jamadar & Crane Khalasi in GP-1,800/- and Loco Pilots (Excluding Shunters).
4.	S&T	Khalasi/Khal Helper re-designated as Helper Gr .II & Gr .I attached to ESM/TCM/WTM and Trolleyman.(GP ₹-1800/-)

In addition to the above, the following categories of staff in GP-1,800/- are also eligible to apply for Voluntary Retirement under LARSGESS in terms of Railway Board's letter no. E(P&A)II-2010/RT-2(RBE No.31/2014) dated 24.03.2014.

- Electrical Power staff.
- Track Machine staff.
- Bridge Staff.
- PWI Khalashi.
- TRD staff

Employees belonging to the above safety categories who fulfills the following conditions are eligible to seek retirement under this scheme:

- Loco Pilots (Excluding Shunters) and other eligible safety staff should have put in minimum 33 years of qualifying service in the category and should be in the age group of 55 to 57 years as on 01.07.2017.
- Employees in GP ₹1,800/- and Trackmaintainer- III in GP ₹1,900/- should have put in minimum 20 years of qualifying service in the safety category and should be in the age group of 50 to 57Years, as on 01.07.2017.
- In terms of Railway Board's letter No. E(P&A) I-2013/FE-2/3 dated 01.12.2014(RBE No.131/2014), for determining the eligibility of the employee in respect of the prescribed qualifying service of 33/20 years under LARSGESS, an employee is required to render total qualifying service of 33/20 years, out of which the employee should have rendered at least the last ten years in one or more than one specified categories which are covered under LARSGESS.

4. The eligibility of the wards for appointment in safety category post with Grade Pay ₹1,800/- under LARSGESS will be as under:

- a. Educational qualification: X Pass(HSLC) or ITI or equivalent.
- b. Eligible staff whose wards possess the qualification of 8th standard pass also may apply which will be considered in exceptional cases. The service conditions and the age of employee as well as ward seeking appointment will be reckoned as on 01.07.2017.

Such of the wards who do not possess 10th pass or ITI on appointment will be given -15 pay band without Grade Pay on appointment. The period spent in 15 pay band will not be counted as service for any purpose as their regular service will start only after they are placed in the pay band PB-1 of ₹5,200-20,200-1,800 GP on their acquiring the minimum educational qualification of 'H.S.L.C. pass, ITI or equivalent' within five years from the date of engagement/appointment in terms of RBE No.102/2012.

- c. Age of the ward to be appointed is to be within: 18 to 31 years (Reaxable by + 5 for SC/ST and + 3 for OBC).

The minimum and maximum age limits as prescribed by Rly Board for recruitment to earstwhile Group 'D' categories is as under (to be reckoned as on 01.07.2017)

UR- 18-31 years
OBC- 18-34 years
SC/ST- 18-36 years

For determining the eligibility for seeking retirement under this scheme, the Grade pay corresponding to the post against which the employee is working on regular basis will be taken into account. Employees in the above mentioned Grade pay will continue to be eligible even after getting financial up-gradation in Grade pay higher than ₹1,900/- under MACPS respectively.


5. The cutoff date for reckoning the eligibility will be 01.07.2017 for all purposes, viz., the age of the employee seeking retirement, his qualifying service, age and educational qualification of the ward seeking appointment etc.
6. Appointment will be done in the lowest recruitment grade in GP ₹1,800/- in the respective department where the employee is working in all cases except loco pilots where appointment will be as ALP in GP-1,900/-. In cases of non-matriculation the pay will be fixed in -15 scale without Grade Pay.
7. The time schedules as advised by Rly Bd, for processing the applications have already been advised. However , the same is reiterated herewith :
 - i. Cut off date for reckoning eligibility of the employee and his ward :1st July, 2017
 - ii. Last date for receiving the applications : 31st July, 2017
 - iii. Scrutinizing the applications : 1st to 31st August, 2017
 - iv. Last date for withdrawal of application : 31st August , 2017

No advance applications will be entertained.

8. Condition of eligibility in the case of ward being considered for appointment would be the same as per prescribed for Direct Recruitment from open market.
9. The request of the employee for retirement under this scheme would be considered only if the ward is being considered suitable for appointment in all respect including medical fitness.
10. In terms of Railway Board's letter no. E(P&A)-2010/RT-2 dated 23.07.2013 (RBE No.72/2013) the written examination for recruitment of wards of Gangmen (Track maintainer) and specified safety categories in GP ₹1,800/- as notified in Board's letter of even number dated 11.09.2010 and 03.01.2012 under LARSGESS has been dispensed. However they will have to qualify the medical tests for relevant category/posts, after verification of educational certificates etc by a committee of three JAG officer.



14. The staff working in construction organization whose lien fixed in LMG Division, may submit their application through Dy.CPO/Con/MLG.
15. In terms of Rly Bd's l/no.E(P&A)I-2011/RT-9 dated 26.07.12, the term 'WARD' will covers only Son and Daughter of the Employee.
