same may be sent to PPS to GM after countersignature of CPO.


It is reiterated here that submission of IPRs within the time is  
mandatory. Non-submission or delayed submission or incomplete submission  
of IPRs will be construed as violation of Railway Service (conduct) Rules.

It has also been intimated vide Railway Board's letter No.  
E(D&A)2011GSI-2 dated 28.10.2011, that officers who do not submit their  
IPRs would be denied Vigilance clearance and will not be considered for  
empanelment for senior level posts in Government of India.

It may please be ensured by Personnel Branch at divisional level that  
IPRs complete in all respect as mentioned above have been submitted by  
Principals/Headmasters of Railway Schools and Private Secretaries Gr.I (Gaz.  
Group-B) working within the divisional jurisdiction and forward the same to  
this office within the target date.

As per Railway Board's directive, IPRs submitted by you are to be  
treated as **SECRET** and should therefore be marked as such. The prescribed  
proforma is enclosed for timely submission of the returns accordingly.
