**TERMS AND CONDITION**

01. The appointment will be on Full Time Contract basis for a period not exceeding one year or till replaced by UPSC selected doctors, whichever is earlier, for the specified STATIONS only.
02. The Contract shall liable to be terminated by giving 15 days notice by either side. Without assigning any reasons, or if the Contract Medical Practitioner is mentally/physically incapacitated.
03. The Contract appointment shall not confer any right for regularisation or absorption in the post or right for continuity in service or automatic extension of the terms of contract.
04. The number of annual terms for engagement of CMPs is upto 12 terms on year to year basis or till attaining the age 60 years whichever is earlier and each term of engagement shall not exceed more than one year.
05. A candidate should not exceed 60 years of age as on 01.04.2018.
06. The Contract Medical Practitioner shall produce certificates of his/her character and antecedents from two gazetted officers of the Central/State Government.
07. Educational/Technical qualification: -
  - (a) **Specialist.** The candidate should possess MBBS with Post Graduate Degree/Diploma in respective subject/field as a specialist and should be registered with Indian Medical Council.
  - (b) **General Duty.** The candidate should possess MBBS Degree and be registered with Indian Medical Council.
08. Monthly remuneration:

**ADDITIONAL TERMS AND CONDITIONS OF THE CONTRACT FOR RETIRED GOVERNMENT  
MEDICAL OFFICERS OF STATE GOVERNMENT AND CENTRAL GOVERNMENT**

01. The appointment will be on Full time Contract basis for a period not exceeding one year or till the regular incumbent joins or attains the age of 65 years whichever is earlier.
02. The contract appointment shall not confer any claim or right for continuity in service or automatic extension of the terms of contract.
03. A candidate should not exceed 65 years age as on 01.04.2018.
04. Monthly remuneration:-  
Rs 46,000/- (PM) (Subject to the condition that remuneration + pension drawn should not exceed the last pay drawn. { The remuneration indicated against each is subject to the condition that no Govt. accommodation is provided if Govt. accommodation is provided, an amount equivalent to the sum of HRA & license fee of the accommodation so provided will be deducted from the monthly remuneration.
05. For retired Govt Medical Officer the number of terms of engagement is 05 in Indian Railway subject to the age limit of 65 years.
