**Sub:- RE-ENGAGEMENT OF RETIRED STAFF ON MONTHLY REMUNERATION BASIS IN EXIGENCIES OF SERVICES IN HQ/UNIT OF MEDICAL DEPARTMENT, N.F.RAILWAY.**

In terms of Railway Board's letter nos. E(NG)-II/2007/RC-4/CORE/1 dated 16.10.2017 & 12.12.2017 & 2017/Trans/01/Policy/Pt.I dated 17.01.2018, it has been decided to fill up following vacancies by Re-engagement of staff, who have retired from Railway service from Nursing, H&MI, Pharmacist, Radiographer, Laboratory Assistant, ECG Technician & Extension Educator cadre.

Hence applications of retired staff who have retired from Railway Service are called for to reach General Manager (P)/MLG's Office on or before **26-07-2018** on following terms and conditions:-

**TERMS AND CONDITIONS OF RE-ENGAGEMENT OF RETIRED STAFF:-**

1. The scheme is valid upto **01.12.2019**.
2. Staff retired from Railway Service from Nursing, H&MI, Pharmacist, Radiographer, Laboratory Assistant, ECG Technician & Extension Educator cadre can only apply.
3. The re-engagement shall be strictly upto the age of **65 years** (OR) till **01.12.2019** (OR) till the availability of regular candidates, whichever is earlier. Senior-most retired re-engaged employees in terms of age will be disengaged first on joining of regular candidates.
4. The maximum upper age limit for the Re-engagement of retired staff is 65 years. The service of re-engaged employee will terminate automatically on completion of **65 years** of age.
5. The Administration is at liberty to terminate the service of the re-engaged employees even before 01.12.2019 by giving 07 days' notice.
6. The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review are not eligible for Re-engagement.
7. The monthly remuneration for re-engaged retired employee is fixed as monthly remuneration determined by reducing pension from his/her last pay drawn (i.e. Basic Pay + DA). The re-engaged retired employees are not entitled for any other benefit or facilities except the monthly remuneration.
8. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
9. Re-engagement shall be subject to prescribed medical fitness for the post.

10. Suitability / Competency of the applicant shall be adjudged before their re-engagement. They may be posted anywhere in AMJ/PNO/MLG/GHY/NGC area as per requirement. **The Re-engaged retired employee will have to give 7 days' Notice for discontinuing the service.**
11. Re- engaged employees shall be on duty as per requirements of the activity center. The duty hours can be changed as per the requirement of work by the administration. The Re-engaged employee will not be eligible for any kind of leave ( like CL, RH, LAP, Sick Leave etc). For absence if any, appropriate deduction will be made from the monthly remuneration.
12. Attested copy of following documents should be attached with the application and it is mandatory.
- Service Certificate.
  - Pensioner Identity Card.
  - Pension Payment Order.
  - Bank Pass Book (1<sup>st</sup> Page) Indicating A/C No. & IFSC Code.
  - PAN Card.
  - Aadhar Card.
  - 03 Passport size Colour Photographs.
13. The last date for submission of the application is **26.07.2018**. Staff retired from Railways desirous for re-engagement, have to submit their applications in the prescribed format at **Annexure-A** addressed to **General Manager (P)/MLG, N.F.Railway, Maligaon, Guwahati-781011** by registered post OR may be dropped in the box kept at 1<sup>st</sup> floor of **General Manager (P)/MLG's Office, Medical/Establishment section** with in **26.07.2018** upto 17.00 hours. Applications received after the cut off date i.e. **26.07.2018** will not be accepted/entertained.
14. Interview will be held on 30-07-2018 at General Manager (P)/MLG's Office. All applicants are advised to attend **General Manager (P)/MLG Office** at 10.00 hours on **30.07.2018** without fail. The applications of those failing to attend the Interview will be summarily rejected.
