Sub: Engagement of **Occupational Therapist (Part Time)** in N.F. Railway on Contractual basis under Central Staff Benefit Fund through **“WALK-IN INTERVIEW”**.

It has been decided to conduct **“Walk – in – interview”** for filling up the posts of **OCCUPATIONAL THERAPIST** on contractual basis (**part time**) under Central Staff Benefit Fund. The terms and conditions mentioned as under:-

1. The selected candidate will be engaged by the Chairman, Central Staff Benefit Fund Committee, N. F. Railway and he/she shall not be considered as a Railway Employee. The engagement will be purely on temporary basis for a **period of one year**, which may be extended further subject to the satisfactory performance of the Consultant from time to time depending upon the requirement and other terms and conditions.
2. Only eligible applicant may appear for **“Walk in Interview”** as per date, time & venue as stated above.
3. There will be no any other allowance admissible from CSBF except monthly Honorarium.
4. The engaged consultant will have to work in Maligaon area for 04 hours in a day **from 09.00 hrs. to 13.00hrs.** five days in a week i.e. from **Monday to Friday** on all working days. Dispensary will remain closed on weekly holidays & other gazetted holidays.
5. If number of candidate is more, then the walk-in- interview may extend to next day as per necessity. So the candidates coming for the interview should be prepared to stay by making their own arrangement.
6. Casual leave of **08 days** shall be permissible to the engaged consultants in a year. No other kind of leave shall be admissible.

7. Deduction will be made on pro-rata basis from the consolidated monthly honorarium for absence period other than weekly holiday & gazetted holidays & casual leave.
8. No TA/DA shall be admissible for appearing in the walk-in-interview. Candidates shall have to make their own arrangement for staying during the selection, if required.
9. No Railway Quarter will be provided to the engaged therapist for the above post. No fooding facility will be provided by the administration.
10. Without hampering the assignment entrusted by the CSBFC/N.F. Railway, the selected candidate can perform private practice.
11. No medical treatment facility, Pass/PTO etc. will be extended by the railway to the selected/engaged candidate.
12. The engaged therapist shall not be allowed to issue any sick & fit certificate in favour of the Railway employees.
13. The contract shall be terminated immediately, if the contract Therapist is mentally/physically incapacitated noticed at any stage during the tenure of contract.
14. The maximum age limit for the aforesaid Therapist (from serial number 1 to 3) has been fixed at 65 years and should be ceased to be engaged after 65 years. The services can be terminated on 14 days' notice by the Chairman CSBF without assigning any reason. The CSBF/NF Railway shall not be bound to assign any reason for such termination and this power may be exercised by the Chairman/CSBF Committee/HQ/MLG only. The therapist have no right to challenge the order of Chairman/CSBF Committee to this effect in any court of Law.
15. The willing candidates may report in the Walk-in-interview with duly filled up prescribed form along with two (02) sets of xerox copies of certificates, testimonials, experience certificates, three (03) passport size photographs as per date, time & Venue mentioned above.
16. In the event of any wrong information/fake academic certificate/testimonials/mis-statement/discrepancy in the particulars being noticed/detected at any stage, the candidature /contract may be cancelled/terminated without any notice and necessary action will be initiated as per Law. Further, No correspondence in this regard will be entertained. No TA/DA would be allowed.
