Sub : Re-engagement of "**Retired staff on Monthly remuneration basis**"
in exigencies of services in **HQ/Unit of Personnel Branch**, N.F. Railway.

In terms of Railway Board's letter No. E(NG)-II/2007/RC-4/CORE/1 dated 16/10/2017 & 12/12/2017 and 2017/Trans/01/Policy/Pt.I dated : 17/01/2018, it has been decided to fill up following vacancies by Re-engagement of staff who have retired from Railway Service from Personnel Department.

Hence, applications of retired staff who have retired from Railway Service are called for to reach General Manager(p)/MLG's Office on or before 04/02/2019 on the following terms and conditions :

TERMS AND CONDITIONS OF RE-ENGAGEMENT OF RETIRED STAFF :

1. The scheme is valid up to 01/12/2019
2. Staff retired from Railway Service from Personnel branch for the post of **OS/E** and any branch/department for the posts of **Peon** can only apply.
3. The re-engagement shall be strictly upto the age of 65 years or till 01/12/2019 or till the availability of regular candidates whichever is earlier. Senior-most retired re-engaged employees in terms of age will be disengaged first on joining of regular candidates.
4. The maximum upper age limit for the re-engagement of retired staff is 65 years. The service of re-engaged employees will terminate automatically on completion of 65 years of age.
5. The administration is at liberty to terminate the service of the re-engage employees even before 01/12/2019 by giving 07 days notice.
6. The employees removed/dismissed/compulsory retired as a result of disciplinary action or in review are not eligible for re-engagement.
7. The monthly remuneration for re-engaged retired employees is fixed as monthly remuneration determined by reducing pension from his/her last pay drawn (i.e. Basic Pay+ DA). The re-engaged retired employees are not entitled for any other benefit or facilities except the monthly remuneration.
8. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
9. Re-engagement shall be subject to prescribed medical fitness for the post.
10. Suitability/competency of the applicant shall be adjudged before their re-engagement. They may be posted in PCPO Office, Maligaon & GHY/PNO area as per requirement. The Re-engaged retired employee will have to give 7 days Notice for discontinuing the service.

11. Re-engaged employees shall be on duty as per requirements. The duty hours can be changed as per the requirement of work by the administration. The Re-engaged employees will not be eligible for any kind of leave (like CL, RH, LAP, sick Leave etc). For absence if any, appropriate deduction will be made from the monthly remuneration.
12. Attested copy of following documents should be attached with the application and it is mandatory.
 - a) Service Certificate
 - b) Pensioner Identity Card
 - c) Pension Payment Order.
 - d) Bank Pass Book (1st Page)
indicating A/C No. & IFSC Code.
 - e) PAN Card.
 - f) Aadhar Card
 - g) 03 Passport size Colour Photographs.
13. The last date for submission of the application is 04/02/2019. Staff retired from Railways desirous for reengagement, have to submit their application in the prescribed format at **Annexure "A"** addressed to **General Manager(P)/N.F. Railway, Maligaon by "Registered post"** or **may submit application at EQ Section, of PCPO's Office, N.F. Railway, Maligaon, Guwahati – 781011 within 04/02/2019 up to 17.00 hours. Applications received after the cut-off date i.e. 04/02/2019 will not be accepted/entertained.**
14. **Interview will be held on 08/02/2019** at General Manager(P)/MLG's Office. All applicants are advised to attend General Manager(P)/MLG office at 10.00 hours on 08/02/2019 without fail. The applications of those failing to attend the interview will be summarily rejected.
