Shortlisted Candidates for Document Verification against Persons with Benchmark Disabilities (PwBD) Quota of CEN 02/2018

1. Based on performance in Computer Based Test (CBT) conducted during the period 17.09.2018 to 17.12.2018 by Railway Recruitment Boards (RRB) for Level-1 posts against CEN 02/2018, candidates bearing Registration Numbers mentioned below have been shortlisted for Document Verification (DV) against PwBD quota.
2. The Registration Numbers are arranged in ascending order and **not** in order of merit.
3. The number of candidates shortlisted for DV is 1.05 times the PwBD vacancies. The purpose of calling 5 % extra candidates over and above the number of PwBD vacancies for DV is primarily to avoid shortfall in the panel. Merely calling a candidate for DV does not , in any way , entitle him /her to an appointment in the Railways.

5. The shortlisted candidates are advised to keep all the required documents for DV as detailed in the notification of CEN 02/2018 in readiness.
