Sub: Re-engagement of retired staff on monthly remuneration basis in exigencies of services in ALIPURDUAR DIVISION, N.F.Railway.

In terms of Railway Board's letter No. E(NG)II/2010/RC-4/6 dated 04.06.2019, No.E(NG)II/2010/RC-4/6 dated 16.11.2010, No.E(NG)II/2007-RC-4/CORE/1 dated 16.10.2017 & No. E(NG)II/2007/RC-4/CORE/1 dated 12.12.2007, it has been decided to fill up following vacancies in ALIPURDUAR DIVISION, N.F.RAILWAY by re-engagement of staff, who have retired from Railway Service on monthly remuneration basis in exigencies of services are as under:-

Hence applications of retired Staff who have retired from Railway Service are called for to reach DRM(P)/APDJ's office on following terms and conditions:-

Terms and Conditions of Re-engagement of retired staff -

- 1) The Scheme is valid upto **01.12.2019**.
- 2) **Staff retired from Railway Service from the categories of Loco Pilot & Technician (C&W) can only apply for respective posts.**
- 3) The re-engagement shall be strictly upto the age of **65 years (OR) till 01.12.2019 (OR) till the availability of regular candidates**, whichever is earlier. Senior-most re-engaged employees in terms of age will be disengaged first on joining of regular candidates.
- 4) The maximum upper age limit for the Re-engagement of staff is **65 years**. The service of re-engaged employee will terminate automatically on completion of **65 years of age**.
- 5) The Administration is at liberty to terminate the services of the re-engaged employees even before **01.12.2019** by giving 07 days' notice.
- 6) The employees Removed/Dismissed/Compulsory retired as a result of disciplinary action or in review are not eligible for Re-engagement. Further employees retired under **SRRS/LARSGESS** will not be eligible.
- 7) The remuneration for re-engaged staff is fixed as monthly remuneration determined by reducing pension from his/her last pay drawn (i.e. Basic + DA). The re-engaged employees are not entitled for any other benefit or facilities except the monthly remuneration.
- 8) The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- 9) Re-engagement shall be subject to prescribed medical fitness for the post.
- 10) Suitability/Competency of the applicant shall be adjudged before their re-engagement duly considering the safety record and safety & other operational requirements. They may be posted anywhere in the Division as per requirement. The Re-engaged Retired employee will have to give **7 days' Notice** for discontinuing the service.
- 11) Re-engaged employees shall be on duty as per requirements of the activity centre. The duty hours can be changed as per the requirement of work by the administration. The Re-engaged employee will not be eligible for any kind of leave (like CL, RH, LAP, Sick Leave, etc.). For absence if any, appropriate deduction will be made from the monthly remuneration.

- 13) Staff retired from Railways desirous for re-engagement, have to submit their applications in the prescribed format at **Annexure-'A' addressed to Sr.Divisional Personnel Officer, Alipurduar Jn., N.F.Railway, DRM/APDJ Office, Pin – 736123 by Registered Post (OR) may be dropped in the Box kept at Welfare Bureau of DRM Office Building/N.F.Railway/Alipurduar Jn.**
- 14) **Screening will be held on 01st Day of EVERY MONTH (or next working day in case of holidays) at DRM(P)/APDJ's office.** All applicants are advised to attend **DRM(P)/APDJ's office at 10.00 hours on 1st Day of EVERY MONTH (or next working day in case of holidays)** without fail.
- 15) Re-engagement is subject to availability of vacancies on date of screening.
