TERMS AND CONDITIONS

1. The appointment will be on Full Time Contract basis for a period **not exceeding one year** or till replaced by UPSC selected doctors, whichever is earlier, for the specified STATIONS only.
2. The Contract shall be liable to be terminated by giving 15 days notice by either side, without assigning any reasons, or if the Contract Medical Practitioner is mentally/physically incapacitated.
3. The Contract appointment shall not confer any right for regularization or absorption in the post.
4. The number of annual terms for engagement of CMPs is enhanced from the 10 terms to 12 terms on year to year basis or till attaining the age of 65 years whichever is earlier and each terms of engagement shall not exceed more than one year.
5. A candidate should not exceed 53 years of age as on **date of appointment(engagement)**.
6. The Contract Medical Practitioner shall produce certificates of his/her character and antecedents from two gazetted officers of the Central/State Government.
7. **Educational/Technical qualification:**
 - a) **Specialist:** The candidate should possess MBBS with Post Graduate Degree/Diploma in respective subject/field as a specialist and should be registered with Indian Medical Council.
 - b) **General Duty:** The candidate should possess MBBS Degree and be registered with Indian Medical Council.
8. **Monthly Remuneration –**

a) For Specialist (Full time)	₹ 95,000/- (PM) (1 st year)
	₹ 1,05,000/- (PM) (2 nd year onwards)
b) For General Duty (Full time)	₹ 75,000/- (PM)

The fee indicated against each is subject to the condition that no Govt. accommodation is provided. If Govt. accommodation is provided, an amount equivalent to the sum of HRA & license fee of the accommodation so provided will be deducted from the monthly remuneration.

- 9. Those doctors who have already been engaged for 12 terms in Indian Railway need not apply.
- 10. These doctors may be posted anywhere in Alipurduar Division, N.F.Railway.
- 11. The engagement is subject to availability of vacancies as on date of Walk-in-Interview.
- 12. Terms & Conditions will be subject to any instructions issued by Railway Board from time to time.

ADDITIONAL TERMS AND CONDITIONS OF THE CONTRACT FOR RETIRED GOVERNMENT MEDICAL OFFICERS OF STATE GOVERNMENT AND CENTRAL GOVERNMENT

- 13. The appointment will be on Full time Contract basis for a period not exceeding one year or till the regular incumbent joins or attains the age of 67 years whichever is earlier.
- 14. The Contract appointment shall not confer any claim or right for continuity in service or automatic extension of the terms of contract.
- 15. A candidate should not exceed 67 years of age as on **date of appointment (engagement)**.

16. Monthly Remuneration -

- a) For GDMO ₹ 75,000/- (PM)
 - b) For Specialist (1st Year) ₹ 95,000/- (PM)
- (Subject to the condition that remuneration + pension drawn should not exceed the last pay drawn)
