**Sub :- Re-engagement of retired staff on monthly remuneration basis in exigencies of services in HQ unit of Stores Department.**

In terms of Railway Board's letter No. E(NG)-II/2007/RC/CORE/1 dated 16.10.2017 & 12.12.2017, it has been decided to fill up of the following vacancies by re-engagement of staff who have retired from Ministerial cadres of Railway services as OS(G) & Ch. OS(G).

Hence, applications are invited, from the retired OS(G) and Ch. OS(G) of PCMM's Office & PCMM/Con/MLG's Office to reach by the office of General Manager(P), N.F.Railway, Maligaon, Guwahati-781011 on or before **20.09.2019** on the following terms and conditions.

**TERMS AND CONDITIONS OF RE-ENGAGEMENT OF RETIRED STAFF :**

- 1) The scheme is valid upto 01.12.2019.
- 2) Staff retired from Railway services from Ministerial cadre (Office Superintendent) can only apply.
- 3) The re-engagement shall be strictly up to the age of 65 years or till 01.12.2019 or till the availability of regular candidates whichever is earlier. The senior most retired re-engaged employee in terms of the age will be disengaged first on joining of regular candidates.
- 4) The maximum upper age limit for re-engagement of retired staff is 65 years. The services of re-engaged will terminate automatically on completion of 65 years of age.
- 5) The administration is at liberty to terminate the service of the re-engaged employees even before 01.12.2019 by giving 07 days notice.
- 6) The employees removed/dismissed/compulsory retired as a result of disciplinary action or in review, are not eligible for re-engagement.
- 7) The remuneration for re-engaged retired employees are fixed as monthly remuneration determined by reducing pension from his/her last pay drawn (i.e. Basic pay + DA). The re-engaged retired employees are not entitled for any other benefits or facilities except the monthly remuneration.
- 8) The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- 9) Re-engagement shall be subject to prescribed medical fitness for the post.
- 10) Suitability/ competency of the applicant shall be adjudged before their re-engagement. The re-engaged staff will be posted in PCMM office, Maligaon/HQ as per requirement. The re-engaged retired employee will have to give 7 days notice for discontinuing the service.
- 11) Re-engaged employees shall be on duty as per requirements. The duty hours can be changed as per the requirement of work by the administration. The re-engaged employees will be eligible for 08 days' leave (on prorata basis) in a calendar year. For absence, if any, appropriate deduction will be made from the monthly remuneration.

All eligible applicants are advised to attend the General Manager(P)/MLG's office at 10.00 Hrs. on 25.09.2019 without fail.
