ENGAGEMENT OF PARA MEDICAL STAFF ON CONTRACT BASIS AGAINST VACANCIES EXISTING IN PARA MEDICAL CATEGORY OF KIR DIVISION, NF. RAILWAY THROUGH WALK-IN-INTERVIEW.

It has been decided to conduct "Walk-in-Interview" for filling up following vacant post of Para Medical staff in the Railway be engaging suitable candidates purely on contract basis. The engagement will be a full time basis on monthly remuneration basis as per Rly Board's letter No.E(NG)/II/2015/RC-4/SC/2 dt.31.05.2019, for a period not exceeding 30.03.2020 (i.e. the validity of the scheme) or appointment/availability of regular selected candidates from Railway Recruitment Board/ or availability of regular railway employees whichever is earlier.

(C) Terms and conditions:-

1. The applicant will be on full time contract basis for a period not exceeding 31.03.2020 or availability of regular selected candidates from RRB (Railway Recruitment Board)/availability of regular railway employee whichever is earlier.
2. The contract shall be liable to be terminated by giving two weeks ' notice by either side without assigning any reason.
3. The contract shall be terminated immediately, if the contract parctioner is mentally/physically incapacitated .
4. The full time contract para-medical staff (CPMS) who enter into contract with the Railways will not have any claim or right for his/her continuity in service or automatic extension of the terms of contract or regularization/absorption in the post.
5. The CPMS shall undergo a medical examination before the contract is entered into, for his/her fitness to perform the work assigned to him/her.
6. At the time of entering into contract, the CPMS shall produce certificate in support of his/her good character and antecedents from two Gazetted officers of the Central /State Govt.
7. At the time of interview & entering into contract, the CPMS shall produce original certificates for proof of his/her date of birth and educational and technical qualification. The candidate belonging to SC/ST/OBC community should bring along with him/her original community (SC/ST/OBC) certificate issued by competent authority in prescribed form the Govt. of India.
