**NOTIFICATION**

Subj: Re-engagement of retired employees on monthly remuneration basis in exigencies of service to work in various posts/categories of N.E. Railway, Mechanical Workshop, Dibrugarh.

Therefore application is hereby invited from retired Railway employees for engagement under the scheme of re-engagement of retired employees in exigencies of service to work in various post/categories of N.F. Railway, Mechanical Workshop, Dibrugarh on monthly remuneration basis for the above posts with the following terms and conditions:-

Terms & Conditions:

1. For the scheme of re-engagement on remuneration basis Railway employees those who have been covered under the Safety Related Retirement Scheme / Liberalized Active Retirement Scheme for Safety staff (LARSGESS) will not be eligible.
2. While engaging such staff, medical fitness of the appropriate category will be adjudged by designated Medical Authority of Railway.
3. Maximum age limit of such re-employment will be 65 years and the limit will not be exceeded during the course of re-engagement of Retired Railway Employees under this circumstances.
4. The scheme is valid up to 01.12.2020
5. Monthly remuneration of retired employees being re-engaged will be determined by following pension from his/her last pay drawal (i.e. Basic Pay + DA).
6. The re-engaged employee will be eligible for any (weight) days of leave on pro-rata basis in a calendar year.
7. Suitability / Competence of the retired staff will also be adjudged before re-engagement and the issue of Safety records as well as the Safety and other operational requirement as needed will also be addressed. Non suitable / not competent employees will be engaged under any circumstances. Decision of the railway administration in this regard shall be final.
8. In the scheme, Railway employees who are voluntarily or compulsorily retired or removed / dismissed from Railway service are not eligible to apply.
9. Re-engaged employee will be discharged immediately on joining of selected candidates from RRBs/ETCs or other source of recruitment or at any time when in the opinion of the administration the exigency ceases to exist or for any other reason that the administration may see to be adverse to the interest of Railway.
10. There shall be no guarantee of consideration of all application for screening test for re-engagement.
11. The exigency in service is purely an administrative decision and the decision of competent authority shall be final in this respect.
12. The payment of monthly basis remuneration will be made through Bank after the last day of the month.
13. The re-engaged retired staff shall have no claim for any benefits as admissible to any temporary or regular railway servants.

The eligible candidates may submit their applications in prescribed format on any working day with attested photo copy of service certificate / PPO / Pensioner Identity Card & Last pay slip along with photo copy of Bank Pass-book with ESK code in the office of the Chief Workshop Manager, N.F. Rly. Mech. Workshop, Dibrugarh. Application may also be sent through Registered post. Target date for receiving application to be CWA/DBWS Office is 31-12-2019. Application received thereafter shall not be entertained. DBWS Administration shall not be responsible for postal delay or any other such causes if occurs.


