“WALK-IN INTERVIEW THROUGH WHATSAPP”

In view of exigencies related with the COVID-19, worldwide pandemic and in view of adequate early preparedness, this has been decided to engage ‘Contract Medical Practitioner’ on temporary basis for a period of 03 months, from the date of such engagement in KIR Division of N.F. Railway from willing/retired eligible doctors, which can be extended purely on administrative requirement and willingness of the concerned CMPs or till the scheme is available, whichever is earlier. A Walk in Interview will be conducted to adjudge the suitability of the willing doctors on the date/time/venue which are provided below. The details of the scheme are given below :-

TOTAL NO. OF VACANCIES - 03 (01 for KIR and 02 for NJP) to meet the requirement of quarantine facility in KIR Division.

Note :-

- (i) The vacancies may be altered as per administrative need at any time during the engagement.
- (ii) The administration reserve the right to place the engaged CMPs anywhere in the jurisdiction of KIR Division (N.F. Railway).
- (iii) Retired Rly Doctors, Retired Govt. Medical Doctors of state government and central government who are physically fit and upto 65 years of age are also eligible.

EDUCATIONAL QUALIFICATION/ELIGIBILITY :-

The candidate should be a minimum MBBS pass degree holder from a recognized institute by the Indian Medical Council with proper registration in IMC or with a valid registration certificate of a state medical council of India after completion of one year of compulsory, rotatory internship. No other certificate will be accepted. Higher qualification, if any, will be given due preference.

AGE :-

- (i) Not exceeding 53 years of age as on 01.03.2020. However age relaxation is admissible for 05 years in case of SC/ST candidate and 03 years in case of OBC candidate.
- (ii) For retired Rly Doctor, Retired Govt. Medical Doctor of state government and central government, age to be considered is 65 years as on 01.03.2020

REMUNERTION :-

- (i) Monthly remuneration is Rs.75,000/- (including HRA & Transport Allowance) for full time General Duty Medical Officer (GDMO).
- (ii) For retired Railway Doctors, retired Government Medical Doctors of State Government and Central Government, the monthly remuneration, as decided by Railway Board, is subject to the condition that the pension plus contractual remuneration of the Retired Doctors should not exceed than the last pay drawn at the time of retirement. No Dearness pay and any other allowances which are admissible to regular Railway Servants shall be admissible to CMP.
- (iii) In case of railway accommodation is provided to the CMP, an amount equivalent to license fees as normal rent of the accommodation so provided shall be deducted from the month fees admissible.



Other Terms and conditions


1. Selected candidate will be subjected to medical examination and only medically fit candidates will be engaged at CMP.
2. The contract Medical Practitioner who enters into contract with Railway will not have any claim or right for his/her continuity or automatic extension of the terms of contract.
3. During the validity of the contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any other ground by giving 15 days prior notice to the Railways. The contract can also be terminated by Railways at any time during the contract by giving 15 days notice without assigning any reasons whatsoever. The contract shall also be terminated by the Railways administration if the CMP is found to be mentally or physically incapacitated.
4. Engagement as CMP will not confer any right for automatic regularization or absorption in Railways.
5. The CMP may avail of free medical treatment for self only except operations categorized as 'Special' in para 622(8) of IRMM 2000 and treatment normally available at super specialty centre from his/her respective zonal railway hospitals during the currency of contract.
6. The details instructions, with regard to the duties while in contract in Railways shall be given to CMP concerned in the event of selection along with the offer of engagement.
7. Appearance in the interview will not vest any right upon the candidate to be engaged at CMP and no reasons will be cited or commutation shall be made with the candidate in the event of candidate not getting selected.
8. The administration reserves absolute right to cancel this notification without assigning any reason(s).
9. No Railway privilege passes/PTOs shall be admissible to the Retired Railway Doctors engaged as CMP in his/her capacity of CMP. However, 'Duty passes', as per eligibility would be provided for outstation duties to the CMPs.
10. The applicants may indicate their preference of posting in the Application form. However, this is not binding on the administration and they are liable to be posted as per administrative requirement.
11. If the candidate conceals any facts, which should have been brought to the notice of the Railway, the whole responsibility will be of the candidate and appropriate action will be taken as per extant rules.
