ENGAGEMENT OF NURSING STAFF FOR COVID CARE CENTRE AT CENTRAL HOSPITAL, N. F. RAILWAY, MALIGAON, GUWAHATI-11

In terms of Railway Board's Letter No.E(NG)II/2005/RC-4/SC/2 dated 28.03.2020 & 31.03.2020 the exigencies related with COVID-19 global pandemic and in view of making adequate preparedness for the said pandemic, it has been decided to engage "**Retired Para- Medical Staff in Gr. C upto age of 65 years or Paramedical Staff (Nursing Superintendent in Level-7)**" on contractual basis for a period of 3 (three) months from the date of such engagement in MD/CH/MLG N. F. Railway, Guwahati-781011 and from the willing eligible Paramedical staff (Nursing Staff), which can be extended purely on administrative requirement and willingness of concerned Paramedical staff or till the scheme is available, whichever is earlier. An online Whatsapp—video Interview will be conducted to adjudge the suitability of the willing Paramedical staff for maintaining social distancing due to COVID-19 pandemic as instructed by the Government of India, for which the date/time along with the details of the scheme are mentioned below:-

2. THE ADMINISTRATION RESERVES THE RIGHT TO PLACE THE ENGAGED STAFFS ANYWHERE IN THE JURISDICTION OF NFR.
3. RETIRED RAILWAY PARAMEDICAL (NURSING STAFF), RETIRED NURSING EMPLOYEES OF STATE GOVERNMENT AND CENTRAL GOVERNMENT WHO ARE PHYSICALLY FIT UPTO 65 YEARS OF AGE ARE ALSO ELIGIBLE TO APPEAR "IN THE "WALK-IN-INTERVIEW".

REMUNERATION:-

- a. The engagement is purely a temporarily measure on Monthly remuneration basis as per Railway Board's letter No. 2017/Trans/01/Policy/Pt.I dtd.12.04.2018 for a period of three months for contractual Nursing Superintendent Level-7 is Rs.44,900/- + other allowances as admissible.
- b. For retired Railway employees, retiree Government Medical employees of State Government and Central Government, the monthly remuneration, as directed by Railway Board, is subject to the condition that the pension plus contractual remuneration of the retired staff should not exceed the last pay drawn at the time of retirement. No Dearness and any other allowances which are admissible to regular Railway Servants shall be admissible.

DATE AND TIME OF Whatsapp-Video-INTERVIEW :-

Eligible and willing candidates should send application through e-mail to spo.engg.mlg@gmail.com on or before **12-07-2020 upto 17:30 hrs** along with the certificate showing date of birth, educational qualification, community and two passport size photographs. Besides these, retired employees should send copy of PPO (Pension Payment Order), Service Certificate & LPC. Date of online Whatsapp-video-interview will be on **13-07-2020 at 10 .00 hrs** onwards.

NOTE:

- (1) The day(s) of interview may extend for more than one day if number of candidate is more.
- (2) There shall be a standby list also to take care of contingent situation as and when selected candidates do not enter into contractual engagement.

OTHER TERMS AND CONDITIONS :

1. Selected candidates will be engaged "CONTRACT PARA MEDICAL STAFF (CPMS) subject to condition that they will have to appear in Medical Examination and to be found medically fit.
2. The CONTRACT PARA MEDICAL STAFF (CPMS) who enters contract with Railways will not have any claim or right for his/her continuity or automatic extension of the term of contract.
3. The contract shall be liable to termination by giving 07 days' notice by either side, without assigning any reasons, or if the CONTRACT PARA MEDICAL STAFF (CPMS) is mentally/ physically incapacitated.
4. Engagement as CPMS will not confer any right for automatic regularization or absorption in railway service.
5. The detailed instructions with regard to the duties while in contract in railway shall be given to CPMS concerned in the event of selection along with the offer of engagement.
6. Appearance in the interview will not vest any right upon the candidate to be engaged as CPMS & no reasons will be cited or communication shall be made with the candidate in the event of candidate not getting selected.
7. The Railway administration reserves absolute right to cancel this notification without assigning any reasons(s).
8. No Railway privilege passes/PTOs shall be admissible to Retired Railway Nursing staff engaged as CPMS in his/her capacity of CPMS. However, 'Duty passes', as per eligibility would be provided for outstation duties to the CPMS.
9. The CPMS shall be governed in respect of matters not referred to in these terms and conditions by any order /amendments to the terms of contract issued by the railway administration from time to time.
10. The remuneration is consolidated and railway will not give any additional perks/facilities.
11. In case of absence of duties proportionate recovery will be made from remuneration.
12. The CPMS shall attend all normal tasks which Para Medical staff is conveniently doing. He/she will also attend to emergencies and accidents.

15. The engagement of paramedical staff is purely for the maintenance of COVID-19 pandemic. Hence the candidate selected and engaged will have to work for COVID-19 pandemic.
