

ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONERS OVER AND ABOVE VACANCIES ON FULL TIME CONTRACT BASIS ON TINSUKIA DIVISION, N.F.RAILWAY.

In view of the exigencies related with the containment and preparedness of COVID-19 pandemic and ramp up medical facilities, it has been decided to engage "Contract Medical Practitioners (CMP)" over and above vacancies on temporary basis for a period up to 31-03-2022 from the date of such engagement under Railway Hospital, Dibrugarh, Tinsukia Division, N.F.Railway from willing, eligible doctors pertinent to COVID-19 related duty only, which can be extended purely on administrative requirement or till the scheme is available, whichever is earlier.

An interview through whatApp call will be held to engage CMPs from open market and from Retired Doctors. The details of the scheme are given below:-

Total No of Vacancies: 08 (Eight) (General Duty Medical Officer).

Since the post are over and above the sanctioned posts due to exigencies on temporary measure, no prescribed community distribution (SC/ST/OBC) is applicable. However, age relaxation will be given to the candidates belonging to SC/ST/OBC categories as per extant rule.

- N.B. 1. THE VACANCIES MAY ALTER AS PER ADMINSTRATIVE REQUIRMENT AT ANY TIME DURING THE ENGAGEMENT. There may be "WAITING-LIST/STAND- BY candidates against the notified panel/select list who may be engaged as per requirement.
2. The administration reserves the right to place engaged CMPs anywhere in the jurisdiction of TSK Division.
3. Retired Railway Doctors, Retired Doctors of State Government and Central Government who are physically fit up to 65 years of age are also eligible for apply.

EDUCATIONAL QUALIFICATION/ELIGIBILITY.

The candidate should be a minimum MBBS pass degree from an institute recognized by the Medical Council of India (MCI) and with registration in MCI, or with a valid registration certificate of any of the State Medical Councils of Indian after completion of one year of compulsory rotatory internship.

AGE: (i) **Not exceeding 53 years of age as on 01-05-2021.** However, age relaxation is admissible to candidates belonging to SC/ST/OBC categories as per extant rule.

(ii) For retired Railway Doctor, retired Government Medical Doctors of State Government and Central Government, age to be considered is **65 years as on 01-05-2021.**

REMUNERATION:

For General Duty (Full Time)	Rs.75,000/- (PM)	The fee indicated against each is subject to the condition that no Govt. accommodation is provided. If Govt. accommodation is provided, an amount equivalent to the sum of HRA and license fee of the accommodation so provided will be deducted from the monthly remuneration.

For retired Railway Doctor, retired Government Medical Doctors of State government and Central government, the monthly remuneration, as decided by Railway Board, is subject to the condition that the pension plus contractual remuneration of the Retired Doctors should not exceed the last pay drawn at the time of retirement. No Dearness and any other allowance which are admissible to regular Railway servants shall be admissible.


Selected candidates will be required to produce original and self attested photocopies of all the certificate showing date of birth, educational/profession qualification, community and four passport size photographs , original P.P.O /Last Pay Certificate (in case retired doctors) at the time of joining.

OTHERS TERMS AND CONDITIONS:

- (I) Services of CMP would be utilized in COVID-19 treatment facility, isolation ward and COVID-19 screening clinic and COVID-19 vaccination programme or any other COVID-19 related duties, hence a through knowledge about the risk involved has be borne in mind. However, any refusal/unwillingness to perform duty related to COVID-19 is liable for termination of the contract.
- (II) Selected candidates will be subjected to medical examination and only fit candidate will be engaged as CMP.
- (III) The Contract Medical Practitioner who enters contract with Railway will not have any claim and right for his/her continuity or automatic extension of terms of contract.
- (IV) During the validity of contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any other ground by giving 15 days prior notice to the Railways. The contract can also be terminated by the Railways at any time during the contract period by giving 15 days notice without assigning any reason whatsoever. The contract shall also be terminated by Railway administration if the CMP is found to be mentally or physically incapacitated.
- (V) Engagement as CMP will not confer any right for automatic regularization or absorption in Railway.
- (VI) The detailed instructions with regard to the duties while in contract with Railway shall be given CMP concerned in the event of selection along with the offer of engagement.
- (VII) Appearance in the interview will not vest any right upon the candidate to be engaged as CMP and no reason will be cited or commutation shall be made with the candidate in the event of candidate not getting selected.
- (VIII) The Railway administration reserve the right to cancel the notification without assigning any reason(s).
- (IX) No Railway privilege passes/ PTOs shall be admissible to CMP. However, 'Duty Pass' as per eligibility would be provided for outstation duties to CMPs.


