**Notice to Non-PwBD candidates declared fit in medical  
category B-2/C-1/C-2 & Below against CEN 02/2018  
Dated: 27-12-2021**

**Sub : Opportunity to Appeal for Re-medical Examination (CEN-02/2018).**

After Document Verification against CEN-02/2018 conducted by RRC/GHY/NFR, candidates were sent for Medical Examination to the Hospitals of Northeast Frontier Railway.

114 candidates whose Roll numbers/Names are given below, were found fit in B-2/C-1/C-2 medical categories and therefore, are not empanelled against CEN-02/2018 due to non-availability of vacant posts in his/her merit position which suits his/her medical fitness status.

**Candidates, who want to prefer appeal for re-medical examination may attend RRC/Guwahati office (Railway Recruitment Cell, Northeast Frontier Railway, Station Road, Guwahati) and submit appeal on any working day on or before 17:00 hours of 25-01-2022. The appeal should be submitted in the format given at Annexure 'B'. The appeal should be submitted along with the proforma for medical certificate to be obtained from a Specialist Doctor given at Annexure 'C' and a Demand Draft (DD) of Rs.1000/- (Rupees One Thousand Only) payable to "PFA, N.F.Railway, Maligaon". After appeal, no further chance will be given for Medical Examination.**

1. The appeal should mention the reason/justification for which the candidate is making the appeal.
2. **The candidate must produce a certificate from a Specialist Government/Private Doctor as per Annexure-C.**
3. Such certificate should contain a note that the Government/Private specialist is fully aware of the physical & visual standards set by the Railway for the particular medical category, and that he is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by railway doctors appointed by the Government in this regard
4. The certificate should bear the photograph and mark of identification of the candidates duly attested by such a Government/Private Doctor.
5. Specialist doctor shall also clearly mention his/her MCI/State registration number.
6. **The appeal should be accompanied by a Demand Draft (DD) of Rs.1000/- payable to "PFA, N.F.Railway, Maligaon".**
7. Candidates whose re-medical is already done need not submit appeal again.

If medical category of such candidates are re-determined on appeal, as B-1(BEE ONE) and above medical categories, then only he/she will be considered for empanelment against CEN-02/2018. The decision of the PCMD of the Railway, whether the appeal of the candidates should be considered for re-examination is final and binding on the candidates.

In case, the decision changes from Unfit to Fit in B-1 (BEE ONE) and above categories, the DD submitted will be returned to the candidates. In all other cases, this DD will be credited to Railway Revenue.

If no appeal is received from the candidates for re-medical examination w.r.t. this notice within the prescribed date, it would be treated as unwillingness to appear for re-medical examination and their candidature against CEN-02/2018 would be cancelled without further notice.

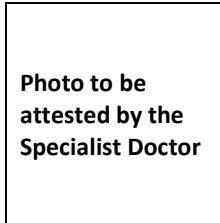
