Sub:- Selection for filling up the post of Jr.Clerk in Level-2 against 33 $\frac{1}{3}$ % DP quota of 'G' Branch.

It has been decided with the approval of competent authority to hold a selection for forming a panel of 08(Eight) Junior Clerks in Level-2 (PB-1 GP Rs 1900/-) of "G" Branch against 33 $\frac{1}{3}$ % of DP vacancies reserved for promotion (UR=06, SC=02, ST=NIL).

ELIGIBILITY CRITERIA

All erstwhile Gr-D staff of Level-1 working under "G" Branch who have completed 02(two) years of continuous service in the relevant grade as on date of notification and for whom no regular avenue of promotion exists may apply to appear in the above selection.

MODE OF SELECTION

As per Railway Board's letter No.E(NG)/2018/PM1/4 dated.14.12.2018 & 14.11.2019, the following guidelines will be followed:-

1. The selection will be done based on the written test and record of service.
2. The written exam shall consist of 01 (one) paper to test the working knowledge of the Railway Servant of the English language and his general standard of intelligence and proficiency through questions in Arithmetic, General knowledge mainly pertaining to Railway matters and matters pertaining to working knowledge of staff along with questions for official language.
3. The question paper will be 100% objective type.
4. All the questions will be of multiple choice only.
5. There shall be no negative marking for incorrect answers.
6. There will be 110 questions. Out of which 10questions (optional) will be on Rajbhasha out of which 100 will have to be answered.
7. If any candidate answers more than 100, the first 100 attempted questions will count.
8. Duration of examination will be 120 minutes.
9. No cutting, overwriting, erasing or alteration of any type in the answer will be accepted. Zero marks will be given for answer having correction/overwriting.

OTHER TERMS AND CONDITIONS

1. All those who qualify on the basis of written test & record of service will be included in the panel in order of their seniority for promotion as per the provision of Para 189 of IREM and RB Estt. No.43/2015 subject to usual relaxation for SC/ST candidates wherever applicable.



2. Since , the promotion is in ministerial cadre, the employee will henceforth be required to possess a typing speed of 30 w.p.m in English or 25 w.p.m. in hindi (typing skill are to be tested on computers). Promotion may however be allowed on provisional basis and concerned staff will be given two years' time from the date of promotion to qualify the prescribed typing proficiency and if they fail to qualify the typing proficiency test within the said period they will be liable to be reverted.
