Document Verification Notice for Non-PwBD Candidates Against CEN 02/2018
(Replacement Panel) Dated 14-08-2022

1. Based on performance in CBT conducted by RRBs against CEN 02/2018 and Physical Efficiency Test conducted by Railway Recruitment Cell/Guwahati (RRC/GHY) for Level-1 posts against CEN 02/2018, the **Document Verification (DV)** of 181 Non-PwBD candidates (Replacement vacancies UR-76, OBC-54, SC-33, ST-09, Extra candidates-09) bearing Roll Numbers given below (attached) is scheduled to be held **on 26-08-2022 at 08:30 am at the Office of Railway Recruitment Cell, Guwahati on Replacement Ground** against non-joining/ resignation etc. of empanelled candidates of Main Panels.

Cut-off scores (Normalised) for this DV for Replacement Panel are given below and candidates may note that no further DVs will be held.

UR-77.12886, OBC-76.17929, SC-70.70392, ST-61.4433.

2. The Roll Numbers are arranged in ascending order and not in order of merit. **No absentee-DV will be held and the candidates are advised to report, without fail, to the venue of DV on 26-08-2022 as per reporting time mentioned in the attached list.** Candidates may also note that no further DVs also will be held against any absentees.
3. The candidature of all the shortlisted candidates for DV is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency/deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRBs/RRCs at any stage of the recruitment process.
4. 09 (Nine) number of candidates shortlisted for DV as extra. The purpose of calling extra candidates for DV over and above the vacancies is primarily to avoid shortfall in the replacement panel. These extra candidates shall be considered for empanelment only if there is shortfall due to absence of other candidates in the list. Merely calling a candidate for DV does not, in any way, entitle him /her to an appointment in the Railways.
5. Link for downloading call letters for DV will be made available on RRC/GHY website shortly.
6. The candidates are advised to carefully go through the instructions contained in the call letters for their DV for information and compliance.
7. The candidates must bring the lower-half-portion (candidate's copy) of admit cards for Computer Based Test (CBT) and Physical Efficiency Test (PET) to be produced during DV without fail.
8. **The candidates must also bring all the required certificates in original in the prescribed proforma as mentioned in para 17 of CEN 02/2018 dated 10-02-2018 (under heading "Verification of Original Documents and Format of Certificates") and para 9 of Corrigendum no. RRBs/CEN 02-2018/Corrigendum-1 dated 28-02-2018. Failure to produce the required documents during DV will lead to disqualification of the candidate and no additional time will be given to the candidates for production of required documents/testimonials.**
9. Candidates found eligible in Document Verification will be directed for medical examination for which they may have to stay for 5-6 days. Candidates are advised to come prepared accordingly.
10. It may be noted that merely calling a candidate for DV does not entitle him/her in any way to an appointment in the Railways. Their consideration for further process of recruitment is subject to them being found eligible in DV and Medical Examination by the Railways.
11. Although utmost care has been taken to publish the details correctly, RRC/GHY reserves the right to rectify any inadvertent errors or typographical/printing mistakes at any stage.
