

NOTIFICATION

A application are invited for engagement of Homeo Consultant by Divisional Staff Benefit Fund Committee/Katihar(not by the Railway) for the Homeo Dispensary being run by the committee under Indigenous system of Medicine of Staff Benefit Fund on SBF committee terms and conditions for a period of one year from the date of engagement. The engagement is not being made against a regular civil post of the Government: rather the job of consultant is purely on contractual basis by the Divisional Staff Benefit Fund Committee of Katihar(not by the Railway) on monthly honorarium basis as those dispensaries are running as a measure of staff welfare under SBF's ISM head.

Total No. of Vacancy :- 01 (For DSBFC, Homeo Dispensary at Railway Hospital,Katihar)

Eligibility — Educational Qualification :- Candidates must have passed B.H.M.S.(along with internship completed) with valid registration. However the candidates possessing the D.H.M.S.(Diploma in Homoeopathic Medicine and Surgery) Should have at last 1 !/2 years working experience(the difference in time period between DHMS & BHMS including internship in the latter) with valid registration.

Age :- The age of candidates should not be more than 69 years as on 01.04.2022.

Remuneration :- Monthly honorarium basis @ Rs.22500/- PM only.

Last date of receipt the application :- on dated 17.12.2022 (17.30 Hrs.) by Welfare Section of DRM(P)/KIR.

Terms and condition —

1. This engagement of a homeopathic doctor will be on a monthly honorarium basis @ Rs.22500/-PM. Only in aggregate.
2. The age of candidates should not be more than 69 years as on 01.04.2022.
3. The candidates may submit their application in the enclosed format of application
4. Candidates will be selected by duly constituted committee on the basis of academic record and interview.
5. At the time of appointment, the following conditions will be followed —
 - I. The scheme is financed by the Central Staff Benefit Fund Committee (not by Railway) and under no circumstances, Homoeo Consultant will be made permanent or regularized as Railway Servant. No facilities admissible to regular Railway Employees are admissible to Homoeo consultant.
 - II. The Service of the selected Homoeo Consultant be terminated on 14 days notice without showing any reasons.
 - III. The working hours will be from 10.00 hrs to 13.00 hrs and from 16.30 hrs, to 17.30 hrs. from Monday to Friday. Timing can be changed in two shifts by the DSBF Committee/Katihar as per the needs of patients. On national holidays, Saturday and Sundays, the dispensary will be fully closed.
 - IV. Homeopathic drugs prescribed will be supplied by CSBFC/DSBFC.
 - V. Private practice is allowed subject to it does not hamper the working hrs.as prescribed in (iii) above.
 - VI. Sr.DPO/KIR as Chairman/DSBFC/KIR will be the controlling Officer.
 - VII. 08 days Casual leave will be admissible in the calendar year.
 - VIII. No TA/DA or other allowances will be admissible for joining.
 - IX. No Pass/PTO will be admissible.
 - X. Since, the scheme is financed by Staff Benefit Fund,engaged doctors will not be eligible for any benefit as admissible to Rly.Staff.
 - XI. Homeo Consultant will be engaged only for one year. Thereafter, it will be the sole discretion of the DSBF Committee to renew the contract on the basis of performance or terminate the consultant for a fresh engagement process. Homeo Consultant so engaged will work as Homeo Consultant for one year contract or 70 years of age, whichever is early. Homeo Consultant will cease to work on the day he reaches 70 years of age without any notice even before completion of 01 year contract from the date of joining. No retirement/termination benefits are admissible.

- XV. All Certificates will be verified from source and in case of any forged document found, suitable action will be taken including police investigation also.
- XVI. Candidates may note that this engagement is entirely part time basis and Railway will never accept their claim for regularization/Permanent.


