**ENGAGEMENT OF CONTRACT MEDICAL PRACTITIONERS ON FULL TIME
CONTRACT BASIS**

It has been decided to engage "Contract Medical Practitioners (CMP)" in Guwahati area under Central Hospital/Maligaon, Northeast Frontier Railway from willing, eligible doctors, which can be extended purely on administrative requirement and willingness of concerned CMP, or till the scheme is available, whichever is earlier.

A walk-in interview will be held on **10.02.2023**. The details of the scheme are given below.

[01 Ophthalmologist , 01 O&G , 02 General Duty Medical Officers]**

Age relaxation will be given to candidates belonging to SC/ST/OBC categories as per extant rule.

N.B.: 1. THE VACANCIES MAY ALTER AS PER ADMINISTRATIVE REQUIREMENT AT ANY TIME DURING THE ENGAGEMENT. In case specialists are not empanelled the vacancies will be filled up by engaging GDMOs. There may be 'WAIT-LISTED/STAND-BY' candidates against the notified panel/ select list who may be engaged as per necessity.

2. The administration reserves the right to place engaged CMPs anywhere in the jurisdiction of Central Hospital/Maligaon.

3. RETIRED RAILWAY DOCTORS, RETIRED DOCTORS OF STATE GOVERNMENT AND CENTRAL GOVERNMENT WHO ARE PHYSICALLY FIT UP TO 68 YEARS OF AGE ARE ALSO ELIGIBLE.

EDUCATIONAL QUALIFICATION/ELIGIBILITY:

The candidate should be a minimum MBBS pass degree from an institute recognized by the Medical Council of India (MCI) and with registration in MCI, or with a valid registration certificate of any of the State Medical Councils of India after completion of one year of compulsory rotatory internship.

AGE: (i) **Not exceeding 53 years of age as on 02.02.2023.** However, age relaxation is admissible to candidates belonging to SC/ST/OBC categories as per extant rule.

(ii) For retired Railway Doctor, retired Government Medical Doctors of State Governments and Central Government, age to be **considered is 68 years as on 02.02.2023.**

REMUNERATION:

For Specialist (Full time)	Rs. 95,000/-(PM) (1 st year) Rs. 1, 05,000/-(PM) (2 nd year onwards)	The fee indicated is subject to the condition that no Govt. accommodation is provided. If Govt. accommodation is provided, an amount equivalent to the sum of HRA & license fee of the accommodation so provided will be deducted from the monthly remuneration.
For General Duty (Full time)	Rs. 75,000/-(PM)	

1. The appointment will be on Full time Contract basis for a period not exceeding one year or till replaced by UPSC selected doctors, whichever is earlier, for the specific STATIONS only.
2. The number of annual terms for engagement of CMPs is 12 terms on year to year basis or till attaining the age of 65 years whichever is earlier and each term of engagement shall not exceed more than one year. For retired Govt. Medical Officer the maximum permissible annual terms of engagement is 10 terms , subject to the age limit of 70 years whichever is earlier. (In terms of Railway Board's letter No. 2020/E(GR)II/1/3-Part(1) dated 18.01.2023)
3. For retired Railway Doctor, retired Government Medical Doctors of State Governments and Central Government, the monthly remuneration, as decided by Railway Board, is subject to the condition that the pension plus contractual remuneration of the Retired Doctors should not exceed the last pay drawn at the time of retirement. No Dearness and any other allowances which are admissible to regular Railway Servants shall be admissible.
4. In case a railway accommodation is provided to the CMP, an amount equivalent to sum of HRA and license fee of the accommodation so provided shall be deducted from the monthly remuneration.

5. Those doctors who have already been engaged for 12 terms in Indian Railway need not apply.

Mode of Selection : The willing eligible candidates should report for the 'Walk in' interview as per schedule with copies of all certificates/testimonials IN ORIGINAL and attested true copies and also two passport size photographs. In the event of any wrong information/fake academic certificates/testimonials etc. the candidates will liable to be taken up under Govt. of India's law in force.

How to Apply : The willing candidates fulfilling the above conditions should advaced scanned copy of their application duly filled/signed as per the enclosed format and scanned copies of certificates/documents mentioned in the Application Form through email on the following email ID **cmpnfr@gmail.com latest by 23.55 hrs of 09.02.2023.**

Selected candidates will be required to produce original and self-attested photocopies of all the certificates showing date of birth, educational/professional qualification, community and four passport size photographs, and, original P.P.O. (Pension Payment Order)/ Service Certificate/ Last Pay Certificate (in case of retired doctors) at the time of joining.

OTHER TERMS AND CONDITIONS:

- (i) Selected candidates will be subjected to medical examination and only fit candidates will be engaged as CMP.
- (ii) Selected candidates must stay in ear marked Railway Accommodation.
- (iii) OBC candidates should submit a proper certificate that they do not belong to the "creamy layer".
- (iv) The Contract Medical Practitioner who enters contract with Railways will not have any claim or right for his/her continuity or automatic extension of the terms of contract.
- (v) During the validity of contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or any other ground by giving 15 days prior notice to the Railways. The contract can also be terminated by the Railways at any time by the Railways during the contract by giving 15 days notice without assigning any reasons whatsoever. The contract shall also be terminated by Railway administration if the CMP is found to be mentally or physically incapacitated.
- (vi) Engagement as CMP will not confer any right for automatic regularization or absorption in Railways.
- (vii) The detailed instructions with regard to the duties while in contract with Railways shall be given to CMP concerned in the event of selection along with the offer of engagement.
- (viii) Appearance in the interview will not vest any right upon the candidate to be engaged as CMP & no reasons will be cited or communication shall be made with the candidate in the event of candidate not getting selected.
- (ix) The Railway administration reserves the right to cancel this notification without assigning any reason(s).
- (x) No Railway privilege passes/PTOs shall be admissible to CMP. However, 'Duty passes', as per eligibility would be provided for outstation duties to the CMPs.
- (xi) **Correct information in regard to details of service as CMP in Railways in Sl. No. 16 of the Application Format should be provided. The same will be verified through AIMS portal by linking AADHAR No., PAN Card to CMP's salary account.**
