Notice to Non-empanelled candidates in Part Panel 1 (CEN RRC-01/2019)

- 1) Part Panel 1 against CEN RRC-01/2019 was published on 20-03-2023. 233 candidates called for DV were not empanelled for the reasons mentioned against the roll numbers in the attached annexure.
- 2) The candidature of candidates who were absent in DV & Medical Examination and who are not eligible as per the notification is hereby cancelled.
- 3) The candidates who are found fit in B-2/C-1/C-2 medical categories and found medically unfit shall be given an opportunity for re-medical examination shortly. A separate notice will be issued on the website to such candidates shortly.
- 4) The remaining cases will be finalized after due verification by the end of May 2023.
- 5) The candidates who were declared temporary unfit (medically) should report to the concerned hospital and get the re-examination done.
- 6) PwBD candidates whose cases are sent to State Medical authorities for review have already been informed over phone & e-mail to submit revised disability certificates to Central Hospital, Maligaon within 01 month.
