TERMS AND CONDITION

1. The appointment will be on Full Time Contract basis for a period **not exceeding one year** or till replaced by UPSC selected doctors, whichever is earlier, for the specified STATIONS only.
2. The Contract shall be liable to be terminated by giving 15 days notice by either side, without assigning any reasons, or if the Contract Medical Practitioner is mentally/physically incapacitated.
3. The Contract appointment shall not confer any right for regularization or absorption in the post.
4. The number of annual terms for engagement of CMPs is enhanced from the 10 terms to 12 terms on year to year basis or till attaining the age of 65 years whichever is earlier and each terms of engagement shall not exceed more than one year.
5. A candidate should not exceed 53 years of age as on **01.10.2023**.
6. The Contract Medical Practitioner shall produce certificates of his/her character and antecedents from two gazetted officers of the Central/State Government.
7. If required Specialists are not available, Railway Administration will have the liberty to select suitable GDMOs against Specialist vacancies.

Educational Qualification/Eligibility :

8. a) For **Specialist** – The candidate should be a minimum MBBS with Post Graduate Degree/Diploma in respective subject/field as a Specialist and should be recognized by the Indian Medical Council .
b) For **GDMO**--The candidate should be a minimum MBBS pass Degree from an Institute recognized by the Indian Medical Council, or with a valid registration certificate of any of the State Medical Councils of India after completion of one year compulsory internship.

8) **Monthly Remuneration-**

a)	For GDMO (Full time)	Rs.75,000/- (PM)	The fee indicated against each is subject to the condition that no Govt. accommodation is provided, an amount equivalent to the sum of HRA & license fee of the accommodation if provided will be deducted from the monthly remuneration.
b)	For Specialist	Rs.95,000/- (PM) (1 st year). Rs.1,05,000/- (PM) (2 nd year onwards)	

- 9) Those doctors who have already been engaged for 12 terms in Indian Railway need not apply.
- 10) These doctors may be posted anywhere in Alipurduar Junction Division, N.F. Railway.
- 11) The engagement is subject to availability of vacancies as on date of Walk-in-Interview.

ADDITIONAL TERMS AND CONDITIONS OF THE CONTRACT FOR RETIRED GOVERNMENT MEDICAL OFFICERS OF STATE GOVERNMENT AND CENTRAL GOVERNMENT.

- 12) CMPs may be terminated after receiving of fresh panel of IRHS doctors or after one year term whichever is earlier if they are selected.
- 13) The contract appointment shall not confer any claim or right for continuity in service or automatic extension of the terms of contract.
- 14) A candidate should not exceed 67 yrs of age as on the date of walk-in-Interview.
- 15) Monthly remuneration :-

a)	For GDMO (Full time)	Rs.75,000/- (PM)	The fee indicated against each is subject to the condition that no Govt. accommodation is provided, an amount equivalent to the sum of HRA & license fee of the accommodation if provided will be deducted from the monthly remuneration.
b)	For Specialist (Full time)	Rs.95,000/- (PM) (1 st year) Rs.1,05,000/- (PM) (2 nd year onwards) Subject to the condition that remuneration + pension drawn should not exceed the last pay drawn.	

- 16) For retired Govt. Medical Officer, the number of annual terms of engagement is 07 in Indian Railway subject to attaining the age limit of 67yrs whichever is earlier.
