Sub: - 04 days Fresh Air Camp for the Non-Gazetted Railway Employees via Flight.

This is to inform that as per minutes taken in agenda dated 29.09.2023 of DSBFC meeting, the Fresh Air Camp for the Non-Gazetted Railway Employees of RNY Division for 2023-24 will be organized At Kolkata-Digha and adjoining areas for 04 days (including journey). The tentative date for the camp will be November last week, for 20(Twenty) Non-Gazetted Railway Employees. The means of travel for selected campers from **Ex - Guwahati to Kolkata and back by Air**. Other local travels from Kolkata to various tourist places will be carried out by AC bus/other suitable vehicle. The details of programme for the camp will be published after the selection of the campers is finalized. **Only Medically/Physically fit will be enrolled as Camper. The Campers will be selected through a lottery among the applicants.** All Non-Gazetted Railway Employees who are willing to join the camp may submit their application through the following Google link - https://docs.google.com/forms/d/e/1FAIpQLSeL3yIAAuixAMRTDcSD-vEinVi0wsNXOnmmLzj3DGkWoQ78Gw/viewform?usp=sf_link, and also hard copy on or before 25.10.2023.


Terms and condition of Fresh Air Camp and other condition are as under: -

1. The Camp will start from LGBI Airport/GHY. Final Date will be intimated later on.
2. The selected campers will join the camp as a batch and travel under the supervision of one officer and CS&WI/S&WI along with one medical practitioner.
3. Maximum 02(Two) dependent (Child/Spouse) as per Pass rules apart from employee will be considered for the camp.
4. Main list of campers will be published by 31.10.2023.
5. **The employee should submit a Family declaration/2023 and proof of I-Card of the ward along with the application.**
6. All campers would maintain strict discipline
7. No Campers should leave the camp without the permission of officer-in-Charge and maintain a schedule.
8. Fooding and Lodging will be provided by the Railways during the camp.
9. **Campers should take care of their luggage by themselves. Camp authorities cannot be held responsible for any loss. Campers must keep warm clothes/Rain Clothes, medicine etc. with them as per hill area and high altitude requirement. Any wards having problems with cold weather, high altitude (where Oxygen layer is thin and causing problems to BP, heart patient etc.) may avoid the Camp.**
10. **Luggage should not exceed the limit admissible to campers for journey.**
11. **All Campers must have their Aadhar Card/Proof of identity and two passport photograph etc. with them as it requires at some places for getting permission to travel or stay.**
12. The scheduled date, time and other details may be informed later on.
13. The schedule programme may be differed due to any exigency or Local weather condition.
14. **Employee who have participated in any camp organized by this Railway/HQ during the LAST 3 YEAR (From 2019 onwards) will not be allowed to participate in the Camp.**
15. Camp Charges will be as under: -
 - A. Level 1 to 5 : - Rs. 100/- + 30% of Air Fare per person.
 - B. Level 6 : - Rs. 300/- + 30% of Air Fare per person.
 - C. Level 7 and above : - Rs. 500/- + 30% of Air Fare per person.
16. 30% of Air fare to be paid before the trip & details of payment will be intimated later on.
17. Campers should be able to adjust to the weather condition & food. The scheduled date of commencement of the camp may be deferred due to unavoidable/unforeseen circumstance with intimation to the campers.


18. The campers should bear the expenses of their food etc. during journey from their respective HQ to station/Airport where camp will officially start and back. The cost of fooding etc. during the camp will be borne from the CSBF from the date, the camp officially begins.
19. The campers will have to utilize their own pass & leave. The date of journey will be intimated in due course, if necessary.
20. Only Vegetarian food will be supplied to the campers as per availability in the locality.
21. All wards of Non-Gazetted Railway employees who are willing to join the camp may submit their applications in the enclosed proforma in Welfare Section of DRM(P)/RNY office on or before 25.10.2023 and also Google Form has to be filed. Application received after 25.10.2023 will not be entertained.
