1. N.F.Railway had conducted written examinations against Employment Notice No.02/2013 (Gr.D) for recruitment in erstwhile Group –D posts in Pay Band – 1 of Rs. 5200 - 20200 with Grade Pay Rs 1800 on 02.11.2014, 09.11.2014, 16.11.2014, 23.11.2014 and 30.11.2014. The Physical Efficiency Test (PET) of the shortlisted candidates except Physically Handicapped (PH) candidates was conducted from 11th February, 2015 to 14th February, 2015. Document Verification (DV) of the shortlisted candidates was done from 23rd February, 2015 to 11th March, 2015 for PH candidates and 19th March, 2015 to 23rd April, 2015 for non-PH candidates. Accordingly, a provisional panel of 20 PH (OH-05, HH-07, VH-08) and 1061 non-PH (UR-550, OBC-280, SC-160, and ST-71) candidates was published on 07.10.2015.
2. A provisional part panel-2 of 59 non-PH (UR-30, OBC-16, SC-11, and ST-02) and the balance final panel of 12 PH (OH-07, HH-01, VH-04) candidates is given below. Roll numbers are in ascending order and not in order of merit. The notified 246 vacancies of ex-servicemen have been distributed in UR, OBC, SC, ST categories in their respective reservation percentages.
3. Offers of appointment will be issued by appointing divisions / units in due course.
4. Further verification of the remaining non-PH candidates shortlisted for document verification is in progress and decision will be taken in due course.
5. Cut off marks for empanelment of non-PH candidates will be published with the final panel.
6. The panel of both PH and non-PH candidates is purely provisional. The community wise distribution of non-PH candidates may undergo change while drawing the final panel. If it is found at any stage of the recruitment / after appointment that the candidate does not fulfill all / any of the conditions of eligibility, his / her candidature / appointment will be cancelled and no appeal against such cancellation will be entertained.
7. Although utmost care has been taken to upload / publish the details correctly, RRC/NFR reserves the right to rectify any inadvertent error at any stage.
