**Employment Notice No. 02/2013 (Gr-D) for recruitment in erstwhile Group-D posts in PB-1 with Grade Pay Rs.1800/-**

**Balance Final Panel of non-PH candidates**

**Date of Panel : 30.05.2016**

1. N.F.Railway had conducted written examinations against Employment Notice No.02/2013 (Gr.D) for recruitment in erstwhile Group –D posts in Pay Band – 1 of Rs. 5200 – 20200/- with Grade Pay Rs 1800/- on 02.11.2014, 09.11.2014, 16.11.2014, 23.11.2014 and 30.11.2014. The Physical Efficiency Test (PET) of the shortlisted candidates except Physically Handicapped (PH) candidates was conducted from 11<sup>th</sup> February, 2015 to 14<sup>th</sup> February,2015. Document Verification (DV) of the shortlisted candidates was done from 23<sup>rd</sup> February, 2015 to 11<sup>th</sup> March, 2015 for PH candidates and 19<sup>th</sup> March, 2015 to 23<sup>rd</sup> April, 2015 for non-PH candidates. Accordingly, a provisional panel of 20 PH (OH-05, HH-07, VH-08 ) and 1061 non-PH ( UR-550, OBC-280, SC-160, and ST-71) candidates was published on 07.10.2015. Further, a provisional part panel-2 of 59 non-PH ( UR-30, OBC-16, SC-11, and ST-02) and the balance final panel of 12 PH (OH-07, HH-01, VH-04 ) candidates was published on 20.01.2016.
2. After verification of records and medical re-examination of few candidates, the balance final panel of 23 non-PH candidates ( UR- 13, OBC-02, SC-07, and ST-01) is given below. Roll numbers are in ascending order and not in order of merit. The notified 246 vacancies of ex-servicemen have been distributed in UR, OBC, SC, ST categories in their respective reservation percentages.
3. The following four candidates who were empanelled against Reserved Categories in provisional panels, are adjusted against ‘UR’ vacancies as per their merit.
