13.	Time period for completion of development works	06 (six) month from the date of issue of letter of acceptance.
14.	Time Period of contract	10 Years from the date of commencement of the work, order for which will be issued by Railway administration. The said order will be issued only after successful completion of the work to be done by the successful bidder with the entire satisfaction of Railway authorities.

Railway website i.e. www.nfr.indianrailways.gov.in during the above mentioned period & same can be downloaded and used as tender documents for submitting the offer. However a Demand Draft for Rs. 3360/- (Rupees three thousand three hundred sixty) only including 12 % GST, drawn in favour of FA & CAO/ N.F. Railway/ Maligaon issued by any Scheduled Bank of India being the cost of tender documents should be enclosed along with the tender while submitting the tender paper/document, if tender paper/ document is downloaded from website. In case the offer is not accompanied by the valid Demand Draft for the cost of the tender documents, the tender will summarily be rejected. The Railway will not be responsible for any delay/difficulties on account of inaccessibility of the down loading facility for any reason whatsoever.
