NOTICE INVITING EOI

Chief Medical Superintendent, NF Railway Hospital, New Jalpaiguri invites Expression of Interest (EOI) from Siliguri based Diagnostic Centres (with NABL/NABH recommended or NABL/NABH/QCI applied for), for clinical investigations including Pathological, Radiological-MRI/CT Scan, PET Scan and Special Investigations etc .

For the purpose a minimum qualifying criteria for empanelment of the Diagnostic Centres has been formulated. The same can be down loaded from the Railway website www.nfr.indianrailways.gov.in along with the application format.

Interested Siliguri based Diagnostic Centres may submit their Expression of Interest (EOI), to Chief Medical Superintendent, N.F. Railway/New Jalpaiguri, if they are willing to extend investigation facilities to the Railway beneficiaries of NJP Railway Hospital (approx 75000 heads) on approved CGHS Guwahati 2014 rate. (In case CGHS rate for a particular investigation is not available then AIIMS's rate or any other government Hospital rate will be applicable).

Investigation centres should make arrangements for collection of samples for Laboratory investigations from New Jalpaiguri Railway Hospital itself.

A. The application/EOI fee is Rs.1000/- (One thousand) only Non refundable which is payable in the form of Demand draft on any nationalized bank in favour of FA & CAO/MLG.

B. Minimum 20% discount of on Non CGHS rate procedures and investigation.

The Agreement will be for a period of **three years** from the date of execution.

The detailed proposals in sealed covers as per instructions in EOI Document addressed to Chief Medical Superintendent, New Jalpaiguri is to be submitted during office hours in the office of Chief Medical Superintendent, New Jalpaiguri Hospital, N.F.
