**EMPANELMENT OF HOSPITALS OF GUWAHATI WITH CENTRAL
HOSPITAL, N. F. RAILWAY, MALIGAON**

EXPRESSION OF INTEREST

Scope of enquiry: - Medical Director/Central Hospital/N F Railway, Maligaon for and on behalf of the President of India, invites Expression of Interest (EOI) from private hospitals Guwahati for empanelment with Central Hospital, Maligaon, N. F. Railway for referral of patients in various specialities on case to case basis. The empanelled hospitals are to render services at par with current CGHS/GHY rate list for various procedures/investigations/services. For items/services/procedures not available at CGHS/GHY rate list, a minimum discount in percentage on the hospital rate list of the private hospital is to be offered. For medicines, disposable/consumables and implants not covered under CGHS/GHY, minimum discounts in percentage on MRP are to be offered. For certain items/procedures, CGHS issues circular on rate list of general nature applicable all over India – rate contained in such circulars will also be applicable.

Eligibility:-

1. Super-specialty private hospital with Level-3 ICU facility or well-equipped Burn Unit will be preferred.
2. Single specialty Eye hospitals having majority of sub-specialties, are eligible to apply.

Terms and conditions:

1. The service provider (i.e. the private hospital) must offer services at CGHS/GHY rate.
2. The private hospital must indicate the specialities & super-specialties in which empanelment is solicited. MD/CH/MLG may depute a team of Doctors to check the infrastructure and Human resource available in the private hospital to take final decision regarding the specialities in which empanelment is to be executed with CH/MLG/NFR.
3. The service provider (i.e. the private hospital) must be willing to render services at par with CGHS/GHY/2014 rate list. Moreover, rates circulated by CGHS on all India basis for various procedures/ items etc. shall also be applicable.
4. The speciality wise services available in the private hospital must be mentioned. However, MD/CH/MLG reserves the right to choose the speciality/specialities in which tie up will be executed. MD/CH/MLG may also depute a team of doctors to inspect the private hospital regarding the availability of infrastructure, Manpower available and location, especially easy accessibility.
5. For NABH/NABL accredited hospital, CGHS rate of NABH/NABL/GHY will be applicable. For non-NABH/NABL accredited hospital, CGHS rate of non-NABH/NABL/GHY will be applicable
6. For non-CGHS items/procedures, the Private hospital has to offer substantial minimum discount in percentage to their hospital rate.
7. For medicines, disposable/consumables and implants not covered under CGHS/GHY, minimum discounts on MRP are to be offered.
8. A Railway beneficiary will be referred to one of the empanelled private hospital for treatment in speciality not available in-house as per his//her choice
9. Duration of contract will be for a period of 2 (two) yrs. Extension will be on yearly basis on mutual consent.

10. The contract may be terminated by 30 days notice from either side.
11. The contract agreement may be terminated by Railway Administration at any time during the currency of the contract agreement for either poor service or loss of eligibility criteria.
12. The rate will be firm during the currency of the contract period. However, any revision of rate by CGHS will be applicable from the date of such rate revision effected by CGHS.
13. The empanelled hospital shall agree to provide free Ambulance service to shift ill patients (patients required to be hospitalized) from Central Hospital, N. F. Railway, Maligaon when so requested.
14. The payment will be on bill system through NEFT/RTGS.
15. Offers of individual private hospital will be processed individually.

Pre-bid meeting: A pre-bid meeting will be held on 08/10/2018 at 1600 hrs. in the chamber of Medical Director, Central Hospital, N F Railway, Maligaon, Guwahati-781011 for any clarification on the EOI

Format for submission of EOI: - The proposal may please be submitted in the format & schedule annexed to this document as Annexure – A, along with supporting documents for the information provided. EOI document with format & schedule is available for free download at our official website <http://www.nfr.indianrailways.gov.in>. The same may also be collected from the office of the Medical Director up to 1200 hrs. of 22/10/2018 .

Last date of submission: The EOI from interested service providers will be received in sealed envelopes up to 1300 hrs of 22/10/2018 in the office of the Medical Director /Central Hospital /N F Railway, Maligaon, Guwahati-781011. The offers will be opened on the same day at 1530 hrs.

Evaluation:

1. The offers from private hospital will be examined as per the eligibility criteria and terms and conditions mentioned above.
2. A team of three doctors constituted by Medical Director will inspect and physically verify the above eligibility and criteria of terms and conditions. The specialities which are to be covered However inspection and physical verification may be waived by MD/CH/MLG for hospitals already inspected by market survey team of doctors of CH/MLG.
