**Sub :- Re-engagement of retired staff on monthly remuneration basis in exigencies of services in Sr. DEN/C/MLG's Unit.**

In terms of Railway Board's letter No. E(NG)-II/2007/RC/CORE/1 dated 16.10.2017 & 12.12.2017, it has been decided to fill up of the following vacancies by re-engagement of Staff who have retired from Ministerial cadres of Railway services as OS(G).

Hence, applications are invited, from the retired OS(G) of Sr.DEN/C/MLG's Office to reach by the office of Sr. Divisional Engineer/Co-ordination, N.F.Railway, Maligaon, Guwahati-781011 on or before 30.11.2019 on the following terms and conditions.

**TERMS AND CONDITIONS OF RE-ENGAGEMENT OF RETIRED STAFF :**

- 1) The scheme is valid up to 01.12.2019.
- 2) Staff retired from Railway services from Engineering Department (Ministerial cadre) (Office Superintendent) can only apply
- 3) The re-engagement shall be strictly up to the age of 65 years or till 01.12.2019 or till the availability of regular candidates whichever is earlier. The senior most retired re-engaged employee in terms of the age will be disengaged first on joining of regular candidates.
- 4) The maximum upper age limit for re-engagement of retired staff is 65 years. The services of re-engaged will terminate automatically on completion of 65 years of age.
- 5) The administration is at liberty to terminate the service of the re-engaged employees even before 01.12.2019 by giving 07 days notice.
- 6) The employees removed/dismissed/compulsory retired as a result of disciplinary action or in review, are not eligible for re-engagement.
- 7) The remuneration for re-engaged retired employees are fixed as monthly remuneration determined by reducing pension from his/her last pay drawn [i.e. Basic pay + DA). The re-engaged retired employees are not entitled for any other benefits or facilities except the monthly remuneration.
- 8) The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- 9) Re-engagement shall be subject to prescribed medical fitness for the post.
- 10) Suitability/ competency of the applicant shall be adjudged before their re-engagement. The re-engaged staff will be posted in Sr.DEN/C/MLG's office, Maligaon as per requirement. The re-engaged retired employee will have to give 7 days' notice for discontinuing the service.
- 11) Re-engaged employee shall be on duty as per requirements. The duty hours can be changed as per the requirement of work by the administration. The re-engaged employees will be eligible for 08 days' leave (on pro-rata basis) in a calendar year. For absence, if any, appropriate deduction will be made from the monthly remuneration.

- b) Pensioner's Identity Card.
- c) Pension Payment Order Copy.
- d) Bank Pass Book (1<sup>st</sup> page) indicating A/C number and IFSC Code.
- e) PAN card.
- f) Aadhar Card.
- g) 03 copies of recent Passport size colour photographs.

13) The last date for submission of the application is 30.11.2019. Staff retired from Railways desirous for re-engagement have to submit their application in the prescribed format at ANNEXURE—A, addressed to Sr. Divisional Engineer/Co-ordination, N. F. Railway, Maligaon, Guwahati- 781011, by Registered Post or may be submitted application in E/Stores section of Sr.DEN/C/MLG Office, N.F.Railway, Maligaon, Guwahati-781011 within 30.11.2019 upto 17.00 Hrs. Applications received after the cutoff date i.e. 30.11.2019 will not be accepted/entertained.

14) Interview will be held on 05.12.2019 at Sr. Divisional Engineer/C/Maligaon office. All eligible applicants are advised to attend the Sr. Divisional Engineer/C/Maligaon office at 10.00 Hrs. on 05.12.2019 without fail. The applications of those failing to attend the interview will summarily be rejected.


