Sub: Missing of one PRS tickets rolls & mismatching thereof.

Going through the case file, it is seen that a wrong series of ticket roll bearing No. 64720200 to 64720399 was supplied instead of serial no-64920200 to 64920399 in the PRS carton Box No. 2, which was received by CS/HJI and entered in the PRS Stock Book accordingly.

On 18.07.2023, the on-duty PRS staff namely Smt. Rinki Dey, CCC/HJI, entered ticket roll containing ticket nos. 64920200 to 64920399 in the system, which was physically missing, instead of PRS Tkt roll containing ticket Nos. 64720200 to 64720399, which was originally & actually present in the stock and also 78 Nos of mismatched tickets were wrongly issued by the concerned staff from ticket No. 64720200 to 64720277. The matter was detected after closure of her shift at 20:00 Hrs and immediately on detection of the fault, a message was issued by CCC/HJI to Comml. Control/LMG with copy to Sr.DCM/LMG, Sr.TIA/LMG and CCMI/LMG vide No. CS/HJI/04/07/23 at 23:32 Hrs of 18/07/23, which may please be seen at SN-3.

Subsequently, on 19/07/23, Sr.TIA/LMG-II visited at PRS/HJI and debited an amount of Rs. 86,88,000/- for missing of PRS ticket roll No. 64920200 to 64920399 (200 Nos. of tickets), vide his Debit Statement No. SPM/HJI/PRS/Spl.Debit/Missing/Tkt/2023-24, dtd 19/07/23 and the same is lying outstanding as Objected Debit at HJI since Aug/23.

Now, it is urgently required to issue a Gazette Notification, regarding misuse of PRS Tkt roll No. 64920200 to 64920399 to pave the way for early clearance of the above station outstanding at HJI station amounting to Rs. 86,88,000/-
