Supervisory staff to whom this Gazette is issued are responsible for seeing that staff under them are made acquainted with orders contained herein and that the signatures of the literate staff are obtained against terms which concern them. Copies of the Gazette should be pasted up at all running sheds and Running rooms. Notices for insertion in the Gazette should be as brief as possible and should reach Dy.CCM/PS & Catg of CCM/G/Maligaon's office not later than the 5<sup>th</sup> of month and must be type written both in Hindi and English in triplicate and framed in the exact form in which they are required to appear in the Gazette.
