**Notification**

Sub:- Re-engagement of Retired staff on monthly remuneration basis  
In exigencies of services for **Gati Shakti Units** in KIR Division.

In terms of Railway Board's L/No.2021/W-1/Genl./Gati Shakti dated 27/07/2022, it has been decided to fill up the following posts in Gati Shakti Unit in KIR Division, N.F. Railway by re-engagement of staff, who have been retired from Indian Railway, on monthly remuneration basis.

Therefore, applications from willing ex-staff, who fulfill the following terms & condition and retired from Railway Service, are invited so as to reach Gati Shakti Unit under DY.CE/GS/KIR office on or before 16/09/2024 up to 17.00 hrs.

**Terms and Conditions are as under:-**

- 1) The re-engagement will be valid for a period of one year from the date of re-engagement and will be extended time to time as per administrative requirements.
- 2) Retired staff who have retired from Indian Railway and is from the same category and same department for which notification is issued can apply.
- 3) All the Railway Retired Supervisor/Supervisors who have not attained 64 years 6 months on the closing date of the notification (to ensure at least six months service is available after re-engagement) for re-engagement purpose will be eligible.
- 4) The administration is at liberty to termination the services of the Re-engaged employees even before completion of his/her term in case their work/conduct is found unsatisfactory

by giving a notice of thirty days. The re-engaged retired staff can be give a notice of thirty days before discontinuing his/her service.

- 5) The employee who was removed/dismissed/compulsory retired as a results of disciplinary action or/and in review are not eligible for re-engagement.
- 6) The re-engaged employees are entitled only for monthly fixed remuneration i.e. reducing pension from his/her last pay drawn (i.e. Basis+DA), at the time of retirement. It is to note that the monthly fixed remuneration plus full pension shall not exceed the last pay drawn at the time of retirement.
- 7) The re-engaged employees will not be eligible for any kind of leave (CL,LAP/LHAP, Sick leave etc.) For absence, if any, during his duty period appropriate deduction from salary/wages will be made from the monthly remuneration.
- 8) The re-engaged employees are not entitled for any other benefits or facilities except the monthly fixed remuneration.
- 9) The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
- 10) The re-engagement shall be subject to prescribed medical fitness for the relevant category.
- 11) Suitability/competency of the applicant shall be adjudged by the nominated committee through personal interview before their re-engaged.
- 12) The duty hours of the re-engaged employees shall generally be 8 hours. However, the duty hours can be changed as per the requirements of the work by administration with weekly off for one day.
- 13) Attested copy of the following documents should be attached with the application and it is mandatory.
  - a) service certificate.
  - b) Pensioners' Identity card.
  - c) Pension Payment Order (PPO)
  - d) Bank Pass Book (1<sup>st</sup> Page) including A/c no. & IFSC code.
  - e) PAN Card
  - f) Aadhar Card
  - g) 03 Recent passport color photographs.
- 14) The last date of submission of the application is 16/09/2024 Staff have to submit their application in the prescribed format (Annexure 'A') in the office of DY.CE/GS/KIR, Gati Shakti on or before 16/09/2024 (till 17.00 hrs). Application received after the cutoff date & time will not be accepted/entertained.
- 15) The date of Interview/screening will be communicated through Mobile No./ Whatsapp. It is mandatory to submit Mobile No./ Whatsapp No. & email address.
- 16) The application of retired staff those who fail to attend the interview will be summarily rejected.


