NOTICE INVITING EXPRESSIONS OF INTEREST (EOI) FROM ALL CGHS EMPANELLED PRIVATE HOSPITALS OR OTHER PRIVATE HOSPITALS WILLING TO PROVIDE SERVICES AT CGHS RATE 2014 GHY UPDATED ON 05 FEB 2024 RATES OR LOWER, AT NEAREST CITY/STATE FOR 02 (TWO) YEARS ON REFERRAL OF RAILWAY BENEFICIARIES SUFFERING FROM CANCER AND REQUIRE MEDICAL TREATMENT LIKE CHEMOTHERAPY, BRACHYTHERAPY AND SURGERY IN ADDITION OF PET SCAN AND CRITICAL CARE FACILITIES FOR NJP-SUB DIVISION, KIR AND APDJ DIVISION.

On behalf of the President of India, Chief Medical Superintendent, New Jalpaiguri Railway Hospital under Ministry of Railways, Government of India, invites offer from CGHS empanelled private Hospitals/Nursing Homes or other Private Hospitals/Nursing Homes willing to provide services at CGHS GHY 2014 Updated on 05 Feb 2024 rates or lower situated at nearest City/State for 02 (two) years to Railway beneficiaries of NJP-Sub Division, KIR and APDJ Division suffering from cancer on being referred by New Jalpaiguri Railway Hospital, N.F.Railway.

Eligibility Criteria:

- (i) Hospital should be preferably currently empanelled under CGHS scheme of Government of India or other private Hospitals willing to provide services at CGHS GHY 2014 Updated on 05 Feb 2024 rates or lower.
- (ii) Hospital should have facilities for state of the art treatment and should have preferably CGHS recognition for the disciplines of Medical Treatment like Radiotherapy/Brachytherapy, Chemotherapy and Surgery in addition of PET Scan and Critical care facilities for Railway Beneficiaries of New Jalpaiguri Sub-Division, APDJ & KIR area.
- (iii) Hospital should have valid Licenses /Registration under relevant state / central Authority to carry out Treatment /Investigation procedures.
- (iv) Selected Hospital will have to submit a Performance Bank Guarantee of Rs.2,00,000 (Rupees Two Lakh) only valid for a period of 30 months before Agreement is finalized.
- (v) The Hospital is to provide services in above specialties as per CGHS rate 2014 GHY Updated on 05 Feb 2024 Non NABH and Non NABL rate (NABH/NABL rates for NABH/NABL accredited Hospital).
 - a. Minimum 20% discount on Non CGHS rate procedures and investigations is to be provided.
 - b. Minimum 15% discount on MRP on consumables items, Medicines and implants (Not covered under CGHS rate) is to be provided.

The period of agreement will be for 02(two) years. The cases referred will at present be limited to diagnosed cancer cases, for Treatment like Radiotherapy/ Brachytherapy, Chemotherapy and Surgery in addition of PET scan and Critical care facilities of Railway Beneficiaries of New Jalpaiguri-Sub Division, APDJ & KIR area.

- A. The application/EOI fee is Rs.1000/- (One thousand) only which is Non refundable and payable in the form of Demand draft on any nationalized bank in favour of FA&CAO/MLG.
- B. A free ambulance service to be provided by private empanelled Hospital to carry patients from NJP Railway Hospital and also at the time of discharge.
